At about 9 P.M., I was reported about the incident by my elder brother Sohroi Rajput while I was working in the factory. He told me that someone killed Ram Nath. Getting this news, I went to the place of occurrence. I found Ram Nath lying dead inside the room. I saw two cut wounds, one on the neck and one on the cheek.

Thereafter, I informed about the incident to the garden Manager. Then, I lodged the F.I.R., which was written by the village gaonbuda at my instance. I had also given my LTI on the F.I.R.

Police came for the investigation on the next morning. The I.O. took the deadbody for autopsy. I met the accused in the garden hospital and on being enquired, the accused told me that he had committed the offence. The accused further told me that he killed Ram Nath in the midst of a quarrel. I handed over the accused to the police. One police officer had performed inquest over the deadbody and prepared a report. I had given my L.T.I. on the said report.

On 13.7.2001, I was working as Associate Professor, Forensic Medicine at A.M.C.H., Dibrugarh. On that day, I performed post-mortem examination on the deadbody of one Ramnath Rajput in connection with Tinsukia P.S. Case No. 257/2000, u/s 302 I.P.C. and found as follows:-

Body Condition:-

A male deadbody of about 20 years, wearing a half pant and a jangia. Eyes and mouth were closed. Natural orifices were healthy. Rigormortis was present on both upper and lower limbs. Blood smear was present on the face.

Injuries:-

- (i) An incised wound over the left cheek, measuring 7x2.5 cm and cutting the lower border of the mandible.
- (ii) An incised wound over the middle of the neck, measuring 4x1 cm and cutting the trachea.
- (iii) An incised wound over the lower neck measuring 4 x 1 cm and skin deep.

Thorax:-

Thoracic organs were pale and healthy. Trachea was found cut.

Abdomen:-

Abdominal organs were pale and healthy. Stomach was healthy but empty.

Cranium and Spinal Canal:-

Cranium and spinal canal were healthy.

Opinion:-

In my opinion, death was caused due to shock and haemorrhage as a result of the injuries described above. In my opinion, injuries were ante-mortem, which might have been caused by heavy sharp cutting weapon and the injuries were homicidal in nature. The person must have died within 12 to 24 hours of autopsy.

Ext.3 is my P.M. report and Ext.3(1) is my signature.

In my opinion, injury Nos. (ii) and (iii) were fatal in nature and these injuries can cause the death of a person individually. These injuries can be caused by an axe.

On 13.7.2000 I was attached to Tinsukia Police Station.  
On that day, one Kunsi Rajput lodged an F.I.R. at Tinsukia P.S.,  
alleging that on the previous night, some unknown person committed  
murder of his son Ram Nath Rajput. This F.I.R. was registered  
as Tinsukia P.S. Case No.257/2000 u/s.302 I.P.C. Ext.4 is the  
F.I.R. and Ext.4(1) is the signature of the then O.C., Tinsukia  
P.S., Inspector Gautam Bora, which is known to me. The case was  
endorsed to me for investigation. I visited the place of occurrence  
at 1 P.M. The dead body was lying inside the house of the  
informant. I had noticed one cut wound on the neck of the deceased.

I had requisitioned the services of one Executive  
Magistrate. Accordingly, Sri Rajen Mahanta also visited the P.O.  
and held inquest on the dead body. Ext.5 is the inquest report  
and Ext.5(1) is the signature of the Executive Magistrate, which  
was given in my presence.

Thereafter, I prepared one sketch map of the P.O. Ext.6  
is the sketch map and Ext.6(1) is my signature. It was followed  
by recording of statements of witnesses.

At the time of my visiting the P.O., the accused was  
also present at home. Till then, I did not get any evidence of

his involvement in the crime. Subsequently, on 15.7.2000 I could know from confidential source that the murder was committed by the accused. Then, I brought the accused to police station for interrogation. The accused confessed before me that he had committed murder of his brother. The accused also stated before me that the deceased was assaulted with an axe which was thrown in the jungle and the accused promised me to lead and produce the weapon of offence.

The accused was brought to the police station on 15.7.2000 at 1.20 P.M. After one hour, the accused was again taken to the P.O. We reached the P.O. at 2.50 P.M. The accused led us to nearby jungle, wherefrom an axe was recovered at the instance of the accused. The axe was seized by me. Ext.1 is the seizure-memo and Ext.1(2) is my signature. Before recovery of weapon, I had taken one Ashok Tassa and Ananda Tanti with me. These persons had witnessed the recovery and seizure. The accused had also put his signature on the seizure-memo.

Ext.7 is the extract of the statement of the accused regarding leading to discovery of the weapon. Ext.7(1) is my signature.

The accused was formally arrested on the same day at 4.10 P.M. The accused was forwarded to Court on the next day. On my transfer from Tinsukia Police Station, the charge-sheet was finally submitted by S.I. Ratul Gogoi on 9.6.2002. Ext.8 is the charge-sheet and Ext.8(1) is the signature of S.I. Ratul Gogoi.

It is not a fact that the accused did not confess his guilt before me. The axe was thrown in bushes and it was not visible. It is a fact that I have not stated this detail in the seizure-memo. It is a fact that <sup>witness</sup> Mansuk Rajput did not say before me that the accused had killed his brother.

It is not a fact that the accused has been challaned in the case without any factive investigation.

(TO THE COURT)

It is a fact that while forwarding the accused to the Court, I did not make any prayer for recording his confessional statement. The seized weapon was also not sent to any forensic laboratory.

Ans:- It is a fact. Someone had inflicted incised wounds.

Q.4. It is also in the evidence of your father that you had confessed before him that you had committed the offence. What is your version ?

Ans:- I didnot confess guilty before my father (PW1).

Q.5. PW3 and the I.O. have also deposed that one axe was recovered from jungle area at your instance. What you have to say ?

Ans:- After the incident, I threw axe, dao and spade of our Basti house in jungle. After 2/3 days of the incident, police called me to the police station. Due to beating of police, I confessed my crime and also led the police officers in the jungle wherefrom the axe was recovered.


Q.6. Would you like to say anything more ?

Ans:- I cannot say who killed my brother. I was in the garden hospital since about 4/5 days prior to the incident due to my stomach pain and body pain. I was informed about the murder by one Sohoral Rajput in the hospital at about 9 P.M. I visited my brother's house in the next morning, then, I saw the deadbody.

Q.7. Would you like to adduce evidence in defence ?

Ans:- Yes.

I, Shri Rajen Mahanta, Circle Officer and Executive Magistrate Tinsukia, along with the Shri Dipak Tamuly, SI, Tinsukia thana and his staff, arrive at the house of deceased Ramnath Rajput, a resident of Nakharai Dhekarigaon, and hold inquest over the dead body upon its identification by Shri Mansuk Rajput, the father of the deceased. The inquest is held in presence of the undersigned witnesses.

The name of the deceased is Ramnath Rajput, S/o Sri Mansuk Rajput, thana Nakharai Dhekarigaon, aged about 20 years. The deceased is found lying supine with his head towards east in the front room of his house. The deceased is clad in black and red coloured half pants. The right hand is bent and is lying on the chest. The left hand is lying bent towards the upper part of the body. The legs are lying straight. Eyes are closed and mouth is slightly open. Two deep cut injuries caused by dao like weapon are seen in the left side of the neck. Hands are fistled. Hairs are black and are about an inch long. 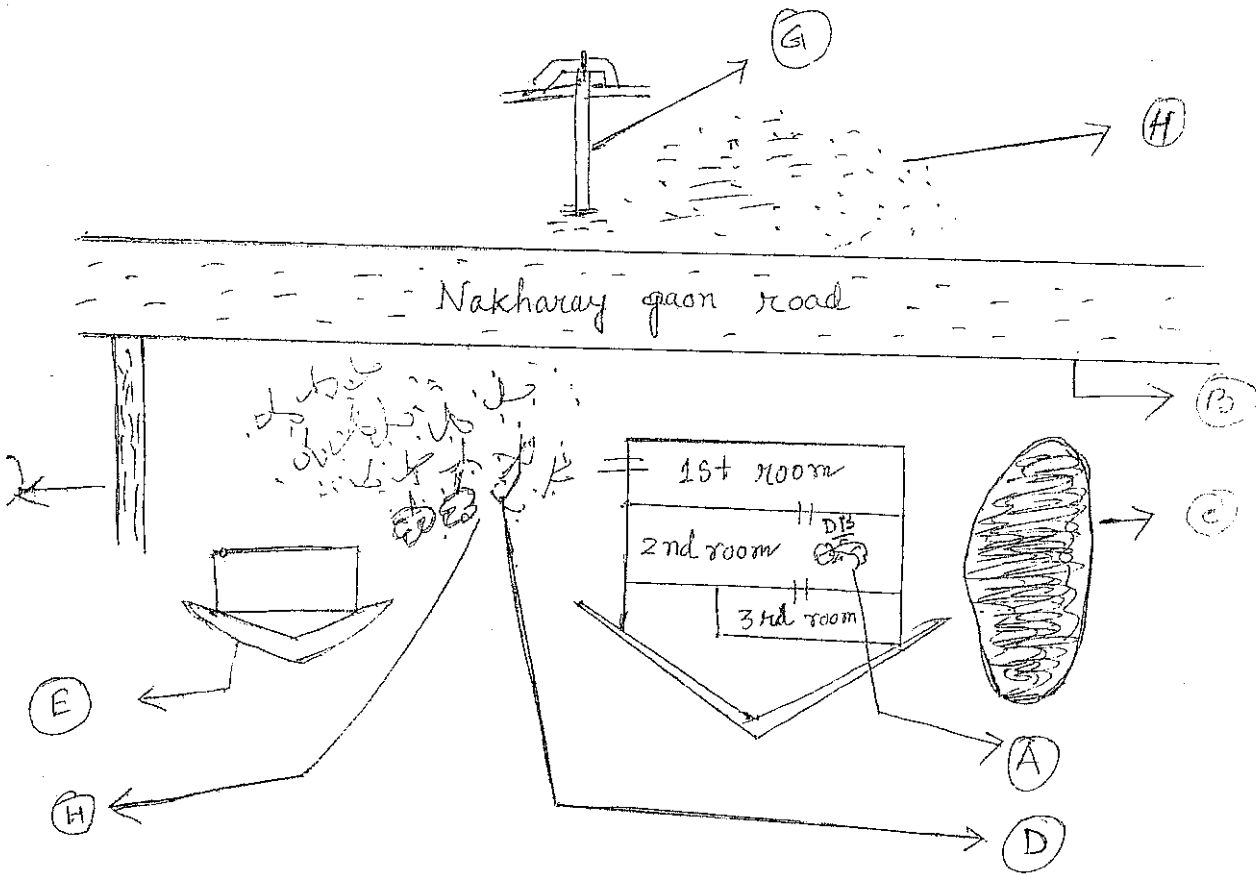
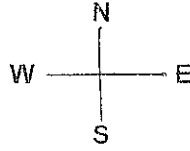
